1. Advertisement on Trolleys:

- a. License Period: Two years, further extendable for One year.
- b. Minimum Reserve License Fee (MRLF): Rs. 30,561/- per month
- c. Earnest Money Deposit (EMD): Rs. 1,00,000/-
- d. Eligibility Criteria:
 - i. The bidder should be an Sole Proprietor/Partnership firm, a Company registered in India, and must be legally competent and financially sound.
 - ii. Bidder shall have minimum three 3 years experience in last 3 years for managing advertisement business at public areas such as Airports, Roads, Sea Port, Railways station, Bus Stop, Malls, Stadium, Shopping complex etc. Relevant proof to be submitted.
 - iii. The Bidding Company must have EPF Registration / licence in its own name for the said business, if applicable. Copy of the said Registration / License should be a part of Submission.
 - iv. The bidding company shall have an average annual turnover (individual / group of companies) of atleast **Rs. 08 Lakhs** in the last two years starting from 2008-2009 from the same business.

2. Foreign Exchange Counter

- a. License Period: Two years, further extendable for One year.
- b. Minimum Reserve License Fee (MRLF) of Rs. 23,350/- per month
- c. Earnest Money Deposit (EMD): Rs. 1,00,000/-
- d. Eligibility Criteria:
 - i. The bidder should be a Bank / Sole Proprietorship/Partnership firm which shall be a Company registered in India, and must be legally competent and financially sound and should possess the valid license from RBI for conducting the Foreign Exchange Business.
 - ii. Bidder shall have experience of operating foreign exchange counter in last 5 years. It shall also have experience of operating atleast 15 branches / counters in India or abroad in last 5 years. Relevant proof to be submitted.
 - iii. The Bidding Company must have required License for operating the said type of licese in its own name. Copy of the said License should be a part of Submission.

- iv. The Bidding Company must have EPF Registration, if applicable. Copy of the said Registration / License should be a part of Submission.
- v. The bidding company shall have an average annual turnover (individual /group of companies) of at least **Rs. 15 Crores** in the last two years starting from 2008-2009.

Any party either a firm or an individual falling under the following categories is not eligible:

- i. De-barred / black listed by CBI/MADC/MIL/AAI or Undertakings / Departments like; Railway, Defence, or any other Department of Govt. of India, State Govt. A declaration to this effect is also to be submitted along with the tender documents.
- ii. Parties either an individual or a business establishment, who has been ordered by a Court of Law to pay the outstanding dues of MADDC/ MIL /AAI at any of the airports as a whole and has not paid such dues to shall also not be eligible for the tender.
- iii. The parties having undisputed dues (including Interest on delayed payments) exceeding one months "License fee" in each contract at Airport/s managed by MIL/ AAI).
