OFFICE ORDER

- 1. Maharashtra Airport Development Company Ltd. (MADC) is a Special Planning Authority (SPA) of the Chhatrapati Sambhaji Raje International Airport (CSRIA) Notified Area at Purandar, Pune vide GR dated 16/07/2018. Being SPA for CSRIA Notified area, MADC has the powers & functions as per the provisions of Section 25, 43, 44, 45, 46, 48, 51, 52 to 58, 89, 90, 107,112, 124K, 135 and 136 of the MR&TP Act 1966, ("Act"). These powers are vested with Vice Chairman and Managing Director, as Chief Executive Officer of the Company, by virtue of Section 152(4) of the said Act.
- 2. For the purpose of effective and efficient implementation of these powers, functions and their extent as approved by the Board in its 64th meeting held on 10/08/2018, delegation of powers for CSRIA has been published in the official Gazette on 24/09/2018 and in local newspapers i.e. Sakal Times & Punyanagari dated 01/10/2018, for the information to Public.
- 3. Now therefore, I, Deepak Kapoor, Vice Chairman and Managing Director, MADC, by this order delegate the powers and functions under various sections of the Act to the officers of the Company as mentioned below:
