## OFFICE ORDER

- 1. Govt. of Maharashtra has appointed Maharashtra Airport Development Company Ltd. (MADC) to be Special Planning Authority (SPA) for the Shirdi Airport notified area, Shirdi vide GR's dated 28/05/2009, 22/11/2018. Being SPA for Shirdi Airport notified area, MADC has the powers & functions as per the provisions of Section 25, 43, 44, 45, 46, 48, 51, 52 to 58, 89, 90, 107,112, 124K, 135 and 136 of the MR&TP Act 1966, ("Act"). These powers are vested with Vice Chairman and Managing Director of the Company as Chief Executive Officer of the Company, by virtue of Section 152(4) of the said Act.
- 2. For the purpose of effective and efficient implementation of these powers, functions and their extent as approved by the Board in its 64<sup>th</sup> meeting held on 10/08/2018, delegation of powers for Shirdi Airport notified area has been published in official Gazette dated 24/09/2018 and in local newspapers i.e. Lokmat Times & Punyanagari dated 01/10/2018, for the information of Public.
- 3. Now therefore, I, Deepak Kapoor, Vice Chairman and Managing Director, MADC, by this order delegate the powers and functions under various sections of the Act to the officers of the Company as mentioned below:
